

# CASWELL TOBACCO EXTENSION NOTES Summer 2016 Season

Hello again,

I think the tobacco crop this year is so different from farm to farm. As I sit here thinking



about the growing season, there is tobacco (3 generations) that we are cultivating, topping, and pulling all at the same time on our farms. Hence, the weather conditions have been extremely variable across the State. I've got some information that I want to share with you that may be helpful to you in making crop decisions.

## Blue Mold Disease Update

As most of you know we found tobacco blue mold disease on three farms here in Caswell County in the middle of June in field plantings. It was also spotted in Eastern Tennessee shortly after we had come in contact with it. Tobacco blue mold is a devastating downy mildew disease caused by the fungus-like organism *Peronospora tabacina*. Blue mold can affect plants in the field throughout the growing season. I began an aggressive fungicide spray program with 10 oz/A Quadris and 4 oz/A of Presidio tankmixed (spraying 20 gallons of water per acre on smaller plants and 50 gallons of water per acre on larger plants) and following up 5 days later with the same formulation or some of the other fungicides labeled for blue mold control (Revus, Orondis Gold 200, Forum, and Acrobat). In some of the other fungicides there had been some resistance buildup; therefore, Dr. Dave Shew (NCSU Plant Pathologists) and myself did not recommend them. We have it under control and there are no active spores present in that affected area. But you need to continuously scout for diseases as well as insects so you can stay on top of it. Hot dry weather and topping flowers out help more than anything.



## NCDA&CS Offers Organic Certification Cost-Share Assistance

Organic growers in North Carolina can apply for partial reimbursement of the cost of becoming certified or for recertification through a program offered by the N.C. Department of Agriculture and Consumer Services. Growers who are certified or recertified between Oct. 1, 2015, and Sept. 30, 2016, can apply for assistance through the program. This cost-share program will cover up to 75 percent of the cost of organic certification for a farm, up to a total of \$750. The program has been popular, and with funds available on a first-come, first-served basis, I would encourage growers to submit their applications early.

Under the grant, operations can be certified and reimbursed in four separate categories: crops, livestock, wild crop and handler/processor. The program is for the 2015-2016 season and is funded through a \$168,000 grant from the U.S. Department of Agriculture. Applications must be postmarked by Dec. 1. To apply, growers must provide a completed application, along with detailed invoices/statements from the certifying agency listing all National Organic Program certified costs, proof of payment, an IRS W-9 form and a copy of your certificate or letter from your certifier if this is a new certification. All charges must be for USDA organic certification. The application can be downloaded at <u>www.ncdaorganic.org</u>.
